### Rules and Regulations

#### World Rank List of the World Barbecue Association

##### General:

The Mission of WBQA shall govern all targets and decisions as well as the one of the World Rank List.

To enter the World Rank List, the team and its Teamchef has to be owner of a World Code, given through WBQA Head Office Switzerland.

This Code can either be received through the national affiliated partner that has to be in good standing, or, being applied through single application to WBQA and its financial responsible at WBQA Head Office. This is called the yearly starting Code of WBQA.

The scores do count as follows:

A: The achieved points on a national championship do count to 100%

B: The achieved points on a continental championship do count 100% plus 25%

C: The achieved points on a world championship count 100% plus 50%

Unequal points receive upgrade to equal points.

If the team compete at several different national and or continental championships the higher score gets into the counting procedure.

A team is allowed, if the national organization does allow international fellowship, to participate for the scoring into World Rank List.

Each year the world rank list Nr. 1 will be published to the medias and the interested members through world mail by WBQA Head Office.

The World Rank List Nr. 1 as well has the right to use the title for the duration of one year as follows:

#### **Barbecue Champion of the World for the year 200.**

An organization that does want to be counted as member of the World Rank List, has to:

1. transmit all participating team contacts and specially the teamchef as WBQA Code owner to WBQA Head Office before the championship gets into its final state.

2. Has to fulfil the license procedure before any further publication, except to the international committee was made and,

3. The license fee is registered at WBQA financial responsible with official accreditation of the event.

4. If the event did take place according the rules and regulations given by the WBQA and its country affiliated, the event is officially sanctioned and counts to the World Rank List.

If these 4 points are fulfilled, the registration will take place .

The world rank list will be updated monthly.

Scores older then 18 month are taken off the counter.
